Please be aware that this agreement is a contract that requires a credit card to reserve all of your appointments. You do not have to pay with the credit card you used to reserve the appointments. The complete cost of all bridal party services will be quoted upon completion of this contract. This contract is required for all bridal parties.

Bridal Hair services require an initial consultation to discuss all matters concerning your big day and experimenting with various options. We require this practice as it ensures perfection and timing to make sure everything runs smooth on your big day.

Please complete and return a copy of the following forms that provide the information necessary to schedule your services. We will contact you within 48 hours of receiving this document with the schedule and details of your services as well as your bridal party.

The terms of this contract are as follows:

- We require a credit card to reserve (not charge) you and your parties' appointments.
- Any appointments cancelled within 10 days of the Wedding Date will be charged for in its entirety.
- You agree to be responsible for all the members of your party or group. If any of the people for whom you have confirmed appointments should cancel without notice, or fail to appear for their appointments, you understand you will be charged for every confirmed appointment and service, including any appointments added on by phone, e-mail, or verbally after this contract is signed.
- You understand that you are responsible for ensuring that you and everyone in your party arrive on time, and that late arrivals will not receive an extension of the scheduled appointment times. (your late arrival or of your party of 10 minutes or more may result in reduced services or regrettably in relinquishment of some or all of the reservations).

- You understand that Hair Expressions is a place of business and that although you may have several service providers servicing you and your bridal party that there are other service providers not involved in your party and servicing other guests. You and your party will be respectful of the other staff and guests.
- We require notification ahead of your wedding day if you plan to bring in outside food and beverages so we can accommodate you. There is no alcohol permitted.
- We are unable to accommodate off sight services.
